

1. ENROLLMENT UPDATE

WE MADE OUR GOAL! Cuyamaca College achieved its 2003-04 FTES goal of 5350! The Final FTES for the college was 5,354.91 or 4.91 over goal – a .23% increase!

To address the new Accreditation Standards, Cuyamaca College is in the process of developing and incorporating student learning outcomes at the course level as well as at the program level through the Program Review process. A "train the trainers" workshop was conducted on July 6th, and representatives from both the Curriculum, General Education and Academic Policies and Procedures Committee as well as the Program Review Committee participated. The goal is to kick-off the curriculum revision process, college-wide, in fall 2004. 4. FIRST ANNUAL COLLEGE CONNECTION

On July 15, 2004, Cuyamaca College's Special Funded Programs partnered with the San Diego County Office of Education-Foster Youth Services, EDFUND, and Alliant International University to host College Connection. Several outside agencies raised over \$4,300 to fund this event.

More than 70 foster youths from all over San Diego County attended Cuyamaca College for a "day in college." This informative event was developed for prospective students to preview support services needed for their educational success. To begin the day, students received a College Connection t-shirt, and filled out admissions and financial aid applications. Activities planned for the students included an orientation, and using "Perri Dollars" students paid for their classes, lunch, and backpacks containing school supplies. Students attended classes in Automotive Technology, Education and Parenting, OH, Paralegal Studies, University Transfer Studies, and CIS. The day concluded with a panel of three successful former foster youths. Kudos to Associate Dean Special Funded Programs, Carmen Solom; Assistant Dean, EOPS, Sandy Lyon; and Financial Aid Assistant, Ray Reyes.
