

#### Q1 Which of the following best describes your current position at the College?





#### Q2 In which division do you teach/work?





#### Q3 Do you currently have adequate internet access to teach or work remotely?





#### Q4 Do you currently have access to a working computer to teach or work remotely?





#### Q5 Does your computer have the software you need to teach your Cuyamaca classes remotely?





### Q6 Do you have the instructional materials you need to teach your class remotely?









#### Q11 How comfortable are you with using Canvas for remote instruction?





#### Q13 Were you aware of the summer training opportunities Cuyamaca College is offering for remote instruction?






