- 1. College Promise: https://mycollegepromise.net/ All faculty should be aware of the College Promise Program. First time students can get their first year of tuition for free. Kim Dudzik went over the eligibility and requirements on the webpage. This will also pay for student health fees, student representation fees, construction fees, and enrollment fees for all Promise scholars in spring and retroactively for fall.
- 2. Update on new Councils: CCC approved the new Institutional Effectiveness Council Charge. This group will be up and running starting spring 19.

This will be brought in during convocation to have faculty staff and students take a survey and give their input. There was a request to clarify the list for students.
